President's Message

The Education study is done! The study experience proved to be thought provoking, and led to interesting discussions due to the wonderful input and participation from our members. The expertise and presentations by several of our members, especially **Joylene Wagner**, **Susan Hallgren** and **Nayiri Nahabedian**, was especially beneficial. Thanks not only to them but also to everyone who participated.

Now that the consensus is in, the National Committee will review the information from all the Leagues and write our position. In March 2012, upon approval of the new position from the LWVUS Board, our new position on the role of Federal Government in Education will be available.

Which leads me to the next project on our list, another study – Privatization of Public Services. You may be asking yourself, why is the League doing two studies in one year? Are we trying to punish ourselves?

What the League studies is the result of a process called Program Planning. State and local Leagues, as well as inter-league organizations do Program Planning every two years. The Program Planning process is an important League tool for identifying issues for study – this is one of the ways we remain a grassroots organization. We will be embarking on program planning this month and the deadline to file the Program Planning form is March 1, 2012. At National Convention which is scheduled for June 2012 in Washington DC, the result of the Program Planning will be discussed and voted on by delegates (approximately 1600 League members) that attend Convention.

When I was in Atlanta, Georgia at National convention in 2010, I was one of the 1,600 delegates that voted during the program planning session. Although I did not vote for the Privatization Study, I did vote for the Education Study. I was surprised when the Privatization Study passed, as many of us felt two studies in

Join us in supporting the SAFE California Act, an initiative in circulation to collect the necessary signatures to qualify for the ballot. Sign up for email alerts, make a donation, and find more ways to get involved on the campaign site.

This initiative would stop executions and replace the death penalty with permanent imprisonment (life without the possibility of parole), including the conversion of existing death sentences to that alternative.

Roll Your Money to LWVGB

A current IRS provision allows those over 70 ½ years of age to roll over up to \$100,000 of their IRA funds (traditional roll over IRA accounts only) to a qualified charitable organization. Such donated funds are not considered as federal taxable income. (However such tax free donated funds may not be counted as a charitable deduction.) For many people, this will be advantageous tax wise. Also, such funds can be considered a part of your "Required Minimum Distribution."

Our League of Women Voters is such a qualified charitable organization. Your IRA holding organization can provide details on how this donation can be arranged. The donation check should be made out to the League of Women Voters of Glendale/Burbank, P.O. Box 21173, Glendale, CA 91221-5273.

Note that the current IRS provision expires December 31, 2011. It is not yet clear if this will be extended, so please act quickly.

Privatization Study

Coming in hot on the heels of our Education study, the League of Women Voters of the United States is now embarking on a study of privatization of government services. The purpose of this study is:

to identify those parameters and policy issues to be considered in connection with proposals to transfer federal, state or local government services, assets and/or functions to the private sector. It will review the stated goals and the community impact of such transfers, and identify strategies to ensure transparency, accountability, and preservation of the common good.

The timeline for this study is shorter than usual—consensus will be due to the National League in May 2012. We are forming our committee, and welcome all members to become involved.

What do we mean by

Privatization

Let's face it. I'm finding the word "privatization" difficult to even spell, let alone understand. But the League of Women Voters of the United States voted to study the issue at its last convention, and I, in my compulsive "I don't want to miss anything" way, offered to chair our local committee.

But as I look at the issue more closely, I see it is an extremely important subject—one that goes to the very heart of our democracy.

What is privatization?

Privatization occurs when a governmental body transfers the providing of service to a private, for-profit entity.

Why is privatization important?

In a word, transparency. In our democracy, public bodies are required to act in the public interest to promote the general welfare, and to conduct the public's business through an open, transparent process. They are accountable to the citizenry. In contrast, private entities exist to enrich the individuals who own it, and the information developed in the course of their business is proprietary to them.

In her background paper on "The Legal Framework of Transparency and Accountability Within the Context of Privatization," Diane Dilanni asks:

Privatization raises particular issues with respect to transparency. When the provision of government services is transferred into private hands, what becomes of the public's right of access to information regarding the provision of those services? <http://www.lwv.org/content/legal-framework-transparency-and-accountability-within-context-privatization>

How does this apply to the cities of Burbank and Glendale?

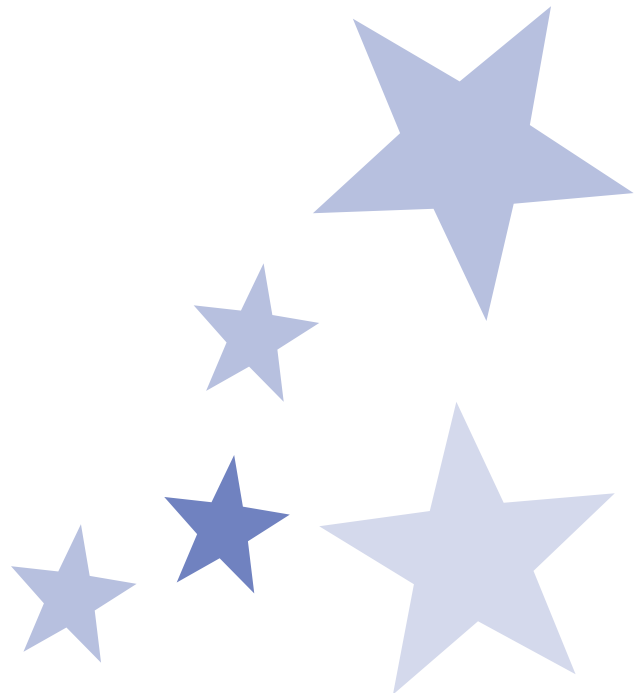

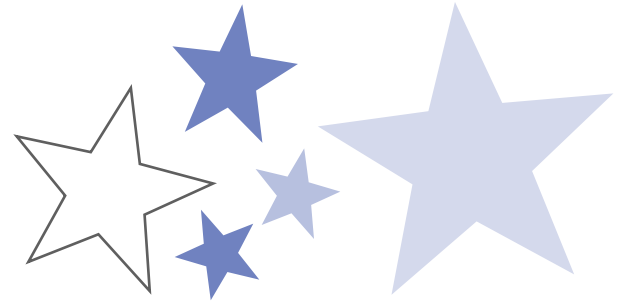


Meet

Jennifer Waggoner

Hometown: San Francisco

Occupation: President, California League of Women Voters



“My name is Jennifer Waggoner.

Californians need fair and balanced information they can trust. They need to know what good government looks like, how to hold government responsible and seek transparency and even be a part of it.”

Jennifer Waggoner is a strong activist for democratic government, and many people say she is a powerhouse. At 38, she is one of the youngest people to be president of the California League of Women Voters (LWVC).

Waggoner is deeply concerned by the fact that Californians are not engaged.

“There are so many barriers to participation,” Waggoner says. “People don’t trust government because they don’t know how it works; and they don’t know how it works because government makes it hard for Californians to engage.”

Her vision for the state is active and informed civic participation by citizens who accept their role in government. “There are lots of forms of civic engagement in addition to voting,” including websites, Skype, and social media marketing.

In the internet age, “people’s expectations are different,” says Waggoner. “They want to participate in ways that are vital, compelling and current. We need to give them the tools and open the process.”

“As a state and particularly as one of the largest economies in the world, we can’t seriously expect to achieve our goals for justice, equality, economic and personal productivity without greater levels of civic engagement. “

Waggoner, a graduate of California’s Claremont-McKenna College said a turning point for her occurred in 2001 when she first voted in San Francisco.

“Dozens of issues were being settled at the ballot box and each had supporters and opponents with strident, contradictory campaign materials. I struggled to find unbiased analysis and, for the first time in my life, I considered not voting because I felt so unprepared.”

It was then that she joined LWVC, “the only consistent source of straightforward election information I could trust.” She became a member of the board in 2007 and president in 2011.

“Participation in government helps us realize our potential as individuals, and the participation of all Californians is how our state will realize its potential,” Waggoner says.
