## UPDATE: Special Election April 13

On December 8, 2009, California State Assembly Member Paul Krekorian won an a seat on the Los Angeles City Council, leaving a vacancy for his seat in the 43rd District of the State Assembly. The Governor has called for a Special Election on April 13, 2010.

The Glendale/Burbank League is planning to hold a Candidates' Forum for the Special Election. The forum is tentatively scheduled to be held in the Burbank City Council Chambers, on a date to be announced shortly.

## Supreme Court Decision: Citizens United v. FEC

Press Release from LWWVUS President Mary Wilson

Washington, DC –The following is a statement by Mary G. Wilson, national president of the League of Women Voters on the Supreme Court's decision in *Citizens United v. FEC*. The League filed an amicus brief in this case:

“The Supreme Court has made a tragic mistake. Their decision announced today in *Citizens United v. FEC* is constitutionally irresponsible and will surely bring about an anti-democratic revolution in how we finance elections in this country. Today, basic pillars of American democracy have been undermined – that elections should not be corrupted by vast corporate wealth and that the voters should be at the center of our democratic system.

“ . . . . the Court has unleashed into our elections tremendous sums of money from for-profit corporations that cannot possibly be matched in quantity by contributions from ordinary citizens.”

*Chief Justice John Paul Stevens dissenting from the majority opinion*

“Justice Stevens had it right when he said, in his dissent, ‘The Court’s ruling threatens to undermine the integrity of elected institutions across the Nation. The path it has taken to reach its outcome will, I fear, do damage to this institution.’

“In creating a new constitutional right for corporations to spend unlimited amounts of their shareholder’s money to determine the outcome in candidate elections, the Court has unleashed into our elections tremendous sums of money from for-profit corporations that cannot possibly be matched in quantity by contributions from ordinary citizens. The only possible outcome of this is that big money and special interests will have an even tighter grip on our democracy.

“Congress and the President enacted campaign finance laws over a series of decades for a reason – to protect our democracy from the perverse influence of big money in our elections. In making this decision, the Court has ignored the best interests of the American public and our representative form of government.”

# California Fair Elections Act

One of the measures on the June 8, 2010 ballot will be the California Fair Elections act.

This measure will make voluntary public financing available to Secretary of State candidates in 2014 and 2018. Authored by Sen. Loni Hancock, D-Oakland, and signed by Gov. Arnold Schwarzenegger, the initiative would establish a

The program would be funded primarily by fees on lobbyists, lobbying firms and lobbyist employers, with no taxpayer dollars going to candidates.

The League of Women Voters of California, along with the California Clean Money

voluntary pilot project that allows candidates running for California secretary of state in 2014 and 2018 to qualify for public financing if they agree to strict spending prohibitions and can show they have a broad base of support by raising a large number of \$5 contributions.

Changing the way we finance elections will allow politicians to stay focused on the jobs they were sent to accomplish. It will open up the political process so any candidate—not just the wealthiest—can pursue elected office.

Action Fund, California Common Cause and the California Nurses Association will co-chair the campaign to pass the California Fair Elections Act.

The League of Women Voters of California strongly supports the California Fair Elections Act so that elected officials can focus on governing instead of fundraising.

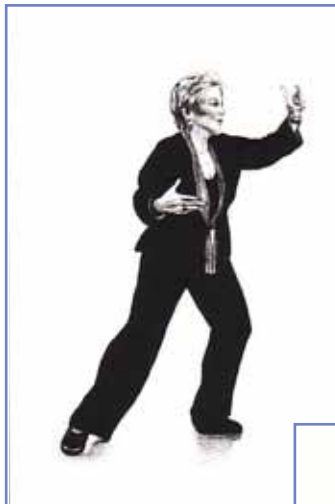
## Information about the 2010 Census

The U.S. Constitution (Article I, Section 2) mandates a headcount every 10 years, of everyone residing in the United States: in all 50 states, Puerto Rico, and the Island Areas. This includes people of all ages, races, ethnic groups, citizens, and noncitizens. The first census was conducted in 1790 and has been carried out every 10 years since then.

The next census occurs in 2010. The population totals from this census will determine the number of seats each state has in the House of Representatives. States also use the totals to redraw their legislative districts.

There are some important changes from the last census. The 2010 Census will be short form only—just 10 questions. The long form is now part of the annual American Community Survey.

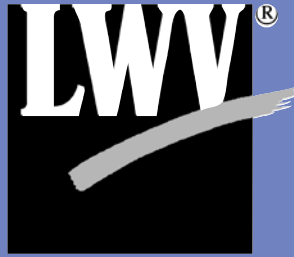
