President's Message

Our annual meeting took place this last month and I wanted to take the opportunity to remind our members of some important items that were determined by those members present at the meeting. We had great member turnout at

a facility that turned out to be most accommodating, the very new Glendale Adult Recreation Center. Besides the usual and necessary tasks of an annual meeting such as approving the minutes, bylaw changes and the budget, our members voted and passed a proposed change in our membership dues.

Our new membership dues increased to \$70.00 per member and \$110.00 per household, our student membership will be \$35.00. The budget committee was reluctant to make the change especially given the challenges of the current economy but we felt we had no other option. Our dues have not increased for seven years, yet our PMP (per member payment) to the state and national offices continue to increase every year. After the PMP there is only a small amount of dues to go towards our local bread and butter activities such as candidate forums, pro/con presentations and distribution of the EasyVoter Guide. Along with the increase in the dues, the budget committee did work hard to

lessen our expenses such as downsizing our PO Box and changing the League phone to a free service – Google voice. We also continue to work towards increasing our membership.

The League's recommended program was decided at the meeting and is as follows:

- Advocacy - Continue to work on campaign finance and ethics reform in both Glendale and Burbank
- Membership Recruitment - Make membership recruitment an integral part of every League program and activity
- Voter Service - Continue to expand Speakers Bureau; Begin preparation for voter registration and other activities related to the Presidential election cycle

We also approved the officers and directors for the years 2011 – 2013. I'm delighted to be the president for the League. I have enjoyed the last two

Redistricting Commission draws the Maps

The Citizens Redistricting Commission has been hard at work, traveling around the state taking testimony from citizens and receiving written comments about how the new Congressional and state legislative district maps should be drawn. The first draft was released on June 10. The crucial second draft will be released on July 14th. The LWV of California has been closely monitoring the process and making public comments on implementing the criterion on respecting the Voting Rights Act. From the very beginning of our Republic, a well-educated citizenry was thought to be essential to protect liberty and the general welfare of the people. Even before the Constitution of the United States was established, the Land Ordinance of 1785 and the Northwest Ordinance of 1787 included responsibilities of the nation for an education system. Education has long been considered a national concern by the federal government. Legislation and Funding for the Education Of Children Who are Disadvantaged

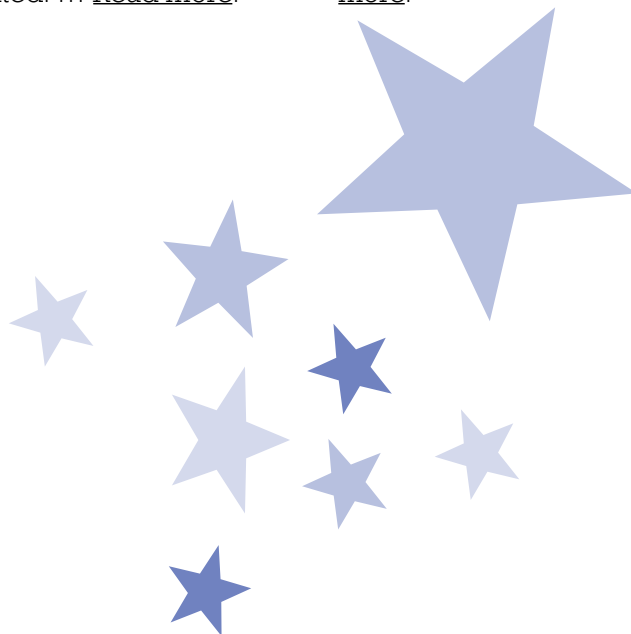

On April 9, 1965, the 89th Congress voted on The Elementary and Secondary Education Act (ESEA, P.L. 89-10). The time from introduction to vote on this bill was only 87 days – a record time for legislation. ESEA was set in the center of President Lyndon Johnson's War on Poverty and was influenced by the Civil Rights Act of 1964. ESEA provided, in a very short time, massive changes in the ways students who differed from the norm by reason of disadvantage would be treated. . . . [Read more.](#)

In the 1960s, the focus of federal policies moved away from redistribution of funds, which lay at the heart of the New Deal, and attempted to place equality of opportunity at the center of the nation's social welfare policies. The Civil Rights Act of 1964 outlawed racial discrimination. This was followed by President Lyndon B. Johnson introducing his education plan (which became the Elementary and Secondary School Act {ESEA}) in 1965. Title VI of ESEA outlawed the allocation of federal funds to segregated programs. . . . The National Association for the Education of Young Children (NAEYC) (1992) creates standards and guidance for early childhood providers across the country. The organization stresses that “programs must be comprehensive in nature, and developmentally appropriate for children so that both age specific and individual characteristics are addressed and designed to meet the needs of children and families served.” Their position statements promote and endorse an integrated, well-financed system of early care and education for the learning and development of all children, including those living in poverty ... Common Core Standards and Assessments

Students who move from one part of the United States to another during their K-12 school careers are likely to encounter substantial variations in curriculum. Standards for student performance vary widely by state. States publish annual reports of Adequate Yearly Progress (AYP), which are required by federal law, but the meaning of “proficient” in those reports can vary widely from one state to another (Cronin, Dahlin, Adkins, & Kingsbury, 2007). The roots of current state-to-state inconsistencies lie in the fact that public education in the United States has traditionally been a local responsibility. The tradition of local governance has led to inconsistent requirements and standards for student performance across the country. ... [Read more.](#)
